We patrol and monitor for pollution in our waterways by using high quality monitoring and sampling technologies to collect water sample. We are part of an enormous effort by watershed organizations to collect and monitor water quality data in Western Pennsylvania. We partner with organizations to amplify efforts to create a scientific and legal approach to improving the water quality in our Three Rivers based on water data and our own patrols and visual assessments.

The presence of the 3RWK boat and kayaks on the three rivers is critical to improve the water quality through visible monitoring and patrols in areas where the threat to water quality is greatest. Threats that require rapid response and monitoring are reported to us by partner organizations, concerned community members, and community groups.

We aim to build lasting relationships with those who utilize the rivers for recreation and empower community members to become vocal water advocates. We inform our communities of the threats to our waterways, involve them in the protection of water quality, and give them the tools to achieve our shared vision of fishable, swimmable, and drinkable water. We also provide technical and legal assistance, mapping tools, and access to available information. We aim to educate and empower a new generation of river stewards.

Our model focuses on scientific and legal advocacy with the aim of holding polluters accountable to the law, particularly through the Clean Water Act. We do this through regular review of water permits, collecting water quality data, and engaging in regulatory proceedings and permit applications. We serve as an enforcer of the nation's clean water laws where state and federal agencies have failed by combining scientific rigor with legal expertise.

#### February 19th

We held our first event of the year with the Pittsburgh section of Outdoor Afro where we went for an educational Walk & Talk at Duck Hollow Trail along the Monongahela River.

#### April 4th

We expanded our Shell Cracker Plant monitoring efforts by increasing to monthly Nurdle Patrols with Mountain Watershed Association & water sampling with 3 Rivers QUEST to understand baseline water quality.

#### May 29th

A train derailment in Harmar Township led to petroleum distillate and nurdles to spill into the mouth of Little Deer Creek along the Allegheny River. We rapidly responded to the incident and continue to monitor the impacts.

#### July 12th

We submitted a formal letter to the EPA regarding a permit for a wastewater injection well in Plum Borough due to the risk it posed to ground and surface water quality from a legal and scientific perspective.

#### October 15th

We celebrated 50 years of the Clean Water Act (CWA) at Pittsburgh's CWA Festival followed by a sunset cruise on the 3 rivers with Rivers of Steel! On the 18th, the actual 50th Anniversary, we partnered with Allegheny Cleanways and Friends of the Riverfront to have a riverfront cleanup in Millvale.

#### December 11th

We were invited to a local scout's meeting to talk about watersheds & pollution sources! It's exciting to see our next generation in action.

#### March 22nd

We celebrated World Water Day by engaging with students at the University of Pittsburgh and at 3 Rivers Outdoor Company about the Clean Water Act and our water protection efforts.

#### April 22nd

We partnered with Allegheny Cleanways for a riverfront cleanup around the mouth of Sandy Creek along the Allegheny River.

#### June 4th

We held our first 3 Rivers Watch event at Kilbuck Boat Launch where we trained volunteers on how to spot and report pollution. We then patrolled for pollution with community members out on the Ohio River on kayaks.

#### August 22nd

Our 3 Rivers Watch program was highlighted in a PublicSource article that spoke on the importance of connecting people to our waterways.

#### November 13th

We held a 3 Rivers Watch training in partnership with Mountain Watershed Association and Beaver County Marcellus Awareness Community on spotting water pollution and nurdles near the Shell plant. The plant announced that it was officially starting operations that following week.
